Through the generosity of individuals in the SPICE (Special Partners in Christian Education) program, local funds are available to help families pay tuition at Central Lutheran School.

These funds are awarded on a needs basis using the most current Federal Poverty Guidelines (see back). Funds will be awarded *only* to those who have:

- 1) applied for a scholarship through Iowa Lutheran School Tuition Organization (ILSTO).
- 2) completed a SPICE application and submitted the necessary paperwork.

A limited amount of SPICE funds is available. God willing, your personal blessings, along with an equitable share of our SPICE funds, will make it possible for your child to attend Central Lutheran School at an affordable cost.

The due date for SPICE, ILSTO, TAC and the tuition worksheet is **April 30, 2018**.
